Meeting called to order: 8 pm.

- 1. Review Minutes
 - a. The minutes of March 19, 2012 were reviewed, amended and adopted.
- 2. Financial Review
 - a. The Repairs and Maintenance Reserve account (number 3104) has not as yet been closed and transferred to account number 5500.
 - b. The electricity bill was a little higher than normal, but otherwise the financial statement does not indicate any untoward expenditure.
 - c. Arrears. The following units are in arrears CP 112, CP 302, HC 208, and HC 301. Fines and interest will be applied.
- 3. Maintenance Items

 - b. Hot water tank replacement Awaiting a quote b/f..
 - c. Building water pressure -b/f.
 - d. Back flow prevention tests in irrigation system is scheduled for April 19th.
 - e. Council discussed the portion of the invoice amount withheld to the painters. The fire place and dryer vents in Hampton Court had been mistakenly painted. There had been concern about this regarding possible consequences over a period of time, especially the dryer vents. Roger Taylor suggested that although there was still concern regarding the dryer vents, some of the money should be released to the painter as the fire place vents no longer appear to be a concern. Council agreed.
- 4. Bylaw Items
 - a. Noise complaint against CP307. Complainant will be asked to obtain police file number for strata records and for levying of a fine.
 - b. There has been a complaint about general noise coming from unit CP 202. The letter did not outline specific times, dates, duration. Council requested this information. A letter was written to the owner, advising that any further issues would result in a fine.

 - a. BC Hydro b/f. No new developments.
 - b. HC317 awaiting information from Baywood Property Management as to whether a letter
