- 1. Review Minutes The minutes of the Strata Council meeting of August 22, 2018, were adopted.
- 2. Financial Review
  - a. August financial statements appear to be over budget for garbage/recycling and hydro; hydro gave us their lowest rate results requested two fold;

  - (c) Depreciation Report no response from RBC Consulting;
  - (d) CP driveway east entrance install angle iron \$4900, paving stones in driveway need repair and conduit \$3100;
  - (e) Garage ramp and surrounding walls need to be pressure washed, the cracks sealed (\$4800) and everything painted;
  - (f) HC front entrance privacy screen aluminum cost \$4200, Shick suggested plexiglass and will get a quote;
  - (g) HC 4<sup>th</sup> floor hallway lights Henneberry had the best price and will be give the go ahead;
  - (j) Painting interior touch-ups quotes will be ordered.
