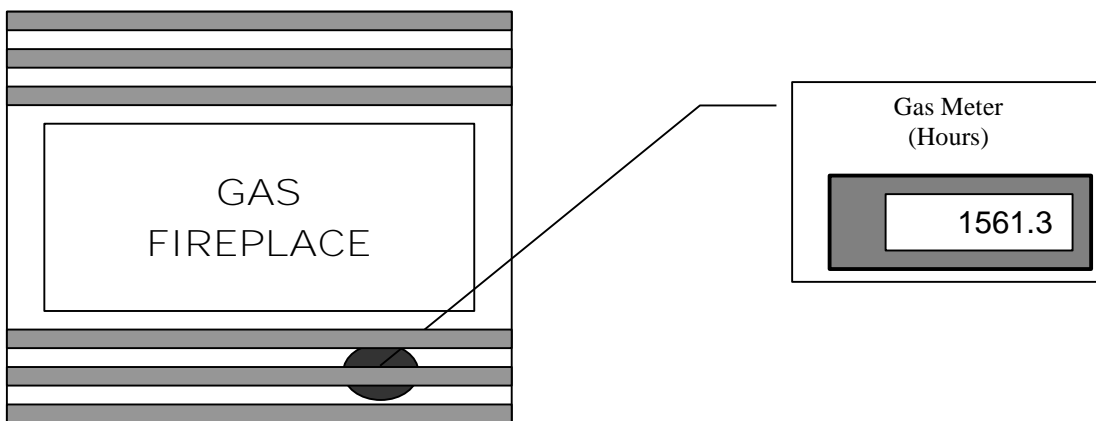

HOW TO READ YOUR GAS METER

The fireplace gas meter is located at the bottom of the fireplace, behind the brass slats. The gas meter is rectangular with a LCD display. The brass slats pop-out easily, if needed, but most gas meters are readable with a flashlight without removing the brass slats.

EXAMPLE:



An owner, tenant, or resident of the unit can provide the gas reading. When submitting your reading, please don't forget to include your suite number, building name, and meter reading. You can submit the gas readings by any of the following methods:

NOTICE TO ALL RESIDENTS OF STRATA 2720

Composting Program Initiative

A number of municipalities are starting voluntary programs for separating organic wastes and this requirement is being considered by the CRD in the near future. Council is interested in proactively responding to help reduce the amount of garbage we send to the landfill and our increasing garbage costs.

The current recycling rate for Hampton Court and Churchill Place is only 20% per year, compared to the CRD average of 40%.

Several Canadian cities, and the province of Nova Scotia, have bans on landfill organics in an effort to reduce the need to build more landfills and also cut greenhouse gas emissions. The CRD has already banned residents putting leaf compost and backyard waste in the garbage. It's quite likely that Victoria will put a ban in place within the next few years, and we'd like to be ahead of the game!

How the compost program works

The program will enable residents to place all their food scraps into individual totes in their units. Compost collection bins will be placed in the parking garage, and emptied and replaced on a regular schedule.

What you need to do

The compost company will supply each unit with its own small compost tote free of charge, but they must be ordered.

Residents who wish to participate are asked to notify council by June 30, 2007. This can be done by:

- checking the "I would like to receive a composting tote for the Composting Program" checkbox on your Gas Meter Reading form (attached),

Don't forget to give your name, unit number and building name when sending/leaving a message.
