# **Appendix A: Proposed Special Resolutions**

### **Special Resolution: 20040316f**

Be it resolved that section 3 of the bylaws of Strata Plan VIS2720 be amended to include the following paragraphs:

### "2. Commencing Legal Action

- (1) The strata corporation is authorized to take all steps necessary to collect monies owed to the strata corporation, including legal action in British Columbia Provincial Court and/or British Columbia Supreme Court, at the discretion of the strata council, provided
  - (a) the monies have been outstanding for a minimum of 6 months, or
  - (b) the outstanding monies are \$2000.00 or more in value."

### **Special Resolution: 20040316g**

Be it resolved that the bylaws of Strata Plan VIS2720 be amended to

- 1) include the amendments as approved at the March 16, 2004 Special General Meeting (or any adjournment); and
- 2) the bylaws with the approved amendments be registered at Land Titles Office in their entirety and that all previous forms of bylaws be repealed.

### Special Resolution: 20040316h

Be it resolved that the strata corporation is authorized to purchase and install security systems up to a maximum value of \$40,000.00. Payment for the system shall come from either contingency reserve, or a combination of contingency reserve and financing, assuming the financing will not cause an increase in current strata assessments.
